Reason for deviation in EPS, NAV and NOCFPS: EPS has significantly increased due to decrease in cost of goods sold being efficient raw material consumption for installation and production of new product facilities after installation of new machinery and Gas Generator. NOCFPS has increased due to increase of collection against accounts receivable and decrease of payment to creditors. NAV has increased due to increase in retained earnings.

Due to (1) High energy cost (2) Lower demand in international market (3) Fall in selling price and (4) Increase in raw material price, the Board of Directors approved the proposal to close down the technologically obsolete Woven Fabric Dyeing, Printing, All over print on Knit fabric and Finishing facilities of the existing factory having capacity of 300 lac yards per year. Earlier, the Board of Directors had approved the decisions for installation of new Accessories and Seamless Dyeing facilities as well as Knit Dyeing and Washing facilities at the existing factory premises at Shafipur, Kaliakoir, Gazipur. Necessary Price Sensitive Information was disseminated on November 07, 2024 and April 29, 2024 regarding the matter. The above Accessories and Seamless Dyeing as well as Knit Dyeing and Washing facilities also had already been installed and started production. The Board of Directors hoped that these upgradations will significantly enhance the company's performance and profitability.
